**Isihloko: Indima yenqununu kunye nezicelo ezivela kubaboneleli-nkonzo bezothutho lwabafundi babucala ukwenzela ilayisenisi zokusebenza ezivela kwi-Provincial Regulatory Entity.**

## 1. Imvelaphi

- 1.1 UMthetho wezoThutho kaZwelonke, 2009 (uMthetho 5 ka-2009), (*Land Transport Act, 2009 (Act 5 of 2009)*), ufuna ukuba zonke izithuthi ezisetyenziswa ngababoneleli-nkonzo bezothutho okanye abantu abathutha abafundi bebasa ezikolweni ngenjongo yokufumana inzuzo eyimali, kufuneka bafumane ilayisenisi zokusebenza kwiqumrhu i-*Provincial Regulatory Entity (PRE)*, enoNdlunkulu walo oseKapa.
- 1.2 Ukufumana ilayisenisi yokusebenza, umboneleli-nkonzo wezoThutho wabucala okanye umntu othutha abafundi ukuya esikolweni (ezikolweni) ngenjongo yenzuzo eyimali makabonelele ngamaxwebhu ahlukahlukeneyo okungqinisiswa kweenkcukacha ngokuthelekiswa nemithetho yezothutho esebenzayo.
- 1.3 Ukuza kuthi ga ngoku, bekulindeleke ukuba ababoneleli-nkonzo bafumane ileta evela kwinqununu, nebingasoloko ineziphumo ezincumisayo kumaxesha amaninzi. Oku, kube negalelo ekubeni ababoneleli-nkonzo abaninzi bangakwazi ukwenza izicelo zelayisenisi yokusebenza nto leyo ebeka ukhuseleko lwabafundi emngciphekweni. Ngenxa yesi sizathu, amagosa eenkonzo zezindlela kweli phondo akubeke phambili ukubeka esweni kwababoneleli-nkonzo abathutha abafundi nto leyo ebangele ukuba kukhutshwe izohlwayo ezikhulu kunye/okanye zikhutshwe izithuthi ezindleleni.

2. **Imiqathango emitsha yezicelo zelayisensi yokusebenza kunye nendima yenqununu**
- 2.1 Ukuphucula ukhuseleko lwabafundi kunye nale nkqubo yesicelo ikhankanywe apha ngasentla, iqumrhu i-*PRE* ifakele izilungiso kwisistim yayo apho umboneleli-nkonzo wezothutho wabucala okanye umntu othutha abafundi ukuya esikolweni (ezikolweni) ngenjongo yokufumana inzuzo eyimali engasayi kufuna leta yenkxaso evela kwiinqununu.
- 2.2 Ngoku, akuba nje umboneleli-nkonzo wothutho wabucala okanye umntu othutha abafundi abase esikolweni (ezikolweni) ngenjongo yokufumana inzuzo eyimali, enze isicelo selayisensi yokusebenza, i-***PRE*** iya kuthumela i-imeyili kwizikolo ezichaphazelekayo **ukucela ubungqina** bokuba bakhona na abafundi ababhalisiweyo esikolweni abanokufuna isithuthi ukusuka kwindawo ethile.
- 2.3 Kubalulekile ukuba uluhlu lweedilesi zabafundi kunye nezinye inkcukacha kwi-*CEMIS* zichaneke, ziphelele yaye zihlaziye.
- 2.4 Kucelwa nijonge **kwisiHlomelo A** esingumzekelo we-imeyili eya kuthunyelwa ezikolweni yi-*PRE*.
- 2.5 Ngokuphendula ngencwadi ebhaliweyo kwi-imeyili ye-*PRE* ukuqinisekisa ukuba ngaba abafundi babhalisiwe na esikolweni okanye akunjalo yaye bahlala kwindawo (kwiindawo) echaphazelekayo, ibhunga lolawulo kunye/okanye inqununu ayinakuthwala uxanduva okanye iphendule ngendlela yokuziphatha kwabaqhubi bezithuthi zothutho lwabafundi okanye ngokungayithobeli kwabo imithetho yendlela kunye/okanye imimiselo esebenzayo.
- 2.6 Ukuqinisekisa ukuba izicelo zisingathwa ngokukhawuleza nangokuyimpumelelo, izikolo ziyacelwa ukuba ziphendule kwi-imeyili ye-*PRE* engadlulanga amaxesha abekiweyo. Esinye isicelo sesokuba izikolo zimbandakanye umphathi weseke the kwimpendulo yaso.
3. Kucelwa nazise okubhalwe kule ngcaciso imfutshane bonke abathathi-nxaxheba abachaphazelekayo ukuze bakuthathele ingqalelo.
