General Information:

Introduction

The After School Game Changer is a critical intervention to enable youth to travel a productive pathway to adulthood. It adds to the educational environment by providing a secure, active and nurturing place, after school hours, that enables learners to explore and pursue their interests and find their niches of success outside of the classroom. In so doing, this Game Changer will build the confidence of learners and their potential future opportunities.

The Western Cape Government has set itself the goal of more than doubling the participation of learners from disadvantaged schools in after school activities, and ensuring regular attendance by significantly improving the attractiveness and quality of such programmes for learners by 2019.

The After School Game Changer targets the following outcomes:

- Improved attitude towards learning
- Improved school outcomes
- Improved school retention
- Improved matric results
- Reduction in risk taking behaviour

Hundreds of school leaders, organisations and practitioners work tirelessly to ensure extended education for learners in the Western Cape. Opportunities are provided through engaging learners in sport, arts, culture, literacy, numeracy and academic support. Strong committed leadership lies at the heart of most programming success. The After School Game Changer and our generous partner in funding and advocating for the strengthening of the after school sector, The Learning Trust, are committed to recognising this leadership and excellence through recognition.

This award builds is a provincial award. The successful nominee will be recognised at the Provincial National Teachers Awards Ceremony which collectively highlight excellence in teaching, leadership, technology-enhanced learning, mathematics and physical science.

Award:

• Winners will receive a floating trophy plus a cash payment of R20 000.00 which will be paid to the school/ centre. The funding may be used to support professional development, ICT integration, reading materials or facility resources which will enhance the teaching and after school offerings at the centre.

Procedures and rules

- The Leadership Excellence Award: After School Programming is a special ministerial Award of the Western Cape Department of Education and the After School Game Changer.
- The shortlisted nominees will be invited to attend an interview where they will be interviewed by an Adjudication Panel, headed by the HOD of Cultural Affairs and Sport, also the lead of the After School Game Changer.
- The Provincial winner will be announced by the Provincial Minister by November 2016.

Nomination process

- School Management Teams, District Offices and External Partners in the After School Programme may nominate candidates for the Award;
- The School Governing Body (SGB) must support the nomination;
- Once nominated, the nomination form should be completed attaching all supporting documentation

Eligibility

- Be a serving principal/deputy principal in a public school registered with the Western Cape Education Department;
- Be employed by the Western Cape Education Department, a School Governing Body in the Western Cape or a management committee of a registered Partial After Care Centre in the Western Cape;
- Be a serving principal/deputy principal in a public school;
- Produce certified proof of SACE certificate or provisional registration.

Entry guidelines and rules

- Entries should be stapled or bound for ease of perusal.
- Entry forms must be filled in correctly, in full and in sequence and with as much information as possible.
- Hand written entries are not encouraged; in cases where this is unavoidable please write legibly.
- Only emailed, posted and hand delivered submissions will be accepted. Faxed entries will not be accepted.
- Evidence should be submitted to support the entry e.g. video's, publications, brochures, CD/DVD, Newspaper clippings (which will not be returned).
- Submission of concise, precise and relevant evidence is emphasised; impact must be demonstrated through evidence.
- Incomplete submissions will not be considered.
- The information provided in the entry form and during the verification process is legally binding.

Assessment and Adjudication Process

- An Adjudication Panel appointed by the After School Game Changer and the Western Cape Education Department will adjudicate on the nominations received and interviews conducted.
