

## NOTICE TO ALL SUPPLIERS/SERVICE PROVIDERS TO THE PROVINCIAL GOVERNMENT OF THE WESTERN CAPE

#### PREFERENTIAL PROCUREMENT REGULATIONS (B-BBEE) IMPLEMENTATION

Please note that in terms of the National Treasury Preferential Procurement Regulations, 2011 the Provincial Government of the Western Cape, with effect from **7 December 2011**, may only award preferential points to suppliers in respect of their B-BEE contribution status. These Regulations together with other relevant legislation can be viewed on www.treasury.gov.za and www.westerncape.gov.za.

All Service Providers MUST submit a B-BBEE Certificates as issued by:

- The verification agencies accredited by the South African National Accreditation System (SANAS) or
- Registered Auditors approved by the Independent Regulatory Board of Auditors (IRBA) in accordance with the approval granted by the Department of Trade and Industry (DTI)

#### COMPULSORY REGISTRATION ON THE WESTERN CAPE SUPPLIER DATABASE (WCSD) BY 1 APRIL 2012

As of **1 April 2012** the Provincial Government of the Western Cape will **ONLY** contract with businesses duly registered on the Western Cape Supplier Database. It must be noted that no service provider will be contracted that fail to submit a valid original Tax Clearance Certificate from the South African Revenue Services (SARS) certifying that its taxes are in order or that suitable arrangements have been made with SARS.

All **prospective** Service Providers are invited to register as a supplier on the Western Cape Supplier Database. Enquiries regarding the registration process may be referred to Mr Andre Bastiaanse at 021 483 5670 or Andre.Bastiaanse@pgwc.gov.za.

WITH EFFECT FROM <u>7 DECEMBER 2011</u> ONLY BIDDERS WITH BBBEE STATUS LEVEL CERTIFICATES ISSUED BY VERIFICATION AGENCIES ACCREDITED BY SOUTH AFRICAN ACCREDITATION SYSTEM (SANAS) OR REGISTERED AUDITORS APPROVED BY THE INDEPENDENT REGULATORY BOARD OF AUDITORS (IRBA) WILL BE ELIGIBLE TO CLAIM PREFERENCE POINTS.

- **Exempted Micro Enterprises (EME's) = Bidders with an annual total revenue less than R5m.**
- 4 Qualifying Small Enterprise (QSE) = Bidders with an annual total revenue between R5m and R35m.
- **♣** Generic Enterprise (GE) = Bidders with an annual total revenue of more than R35m.
